Cacao butter is made by pressing ground, milled Cacao nibs to make a cocoa paste. This process separates the butter from the powder. The butter is solidified and moulded into wafers. Cocoa butter contains a high proportion of saturated fats, derived from healthy acids - stearic and palmitic. Our Organic Cacao Butter is certified

organic by the Soil Association under the code GB-ORG-05.


